The Number and Composition of County Commission Districts Committee meeting was held to hear remarks by invited guest Mayor Jerry L. Demings concerning the number and composition of county commission districts; to vote on a recommendation to the full CRC; and to discuss the subcommittee final report

Chair Douglas thanked the members and the public for their attendance.

#### Public Comment

No members of the public addressed the committee during public comment.

# Committee Discussion of Full Time or Part Time

Chair Douglas opened the discussion on full or part time positions. Member Drake stated that he does not see the need for the committee to consider full or part time positions for the commission. Member Wynn agreed.

Member Klein agreed with his committee members and provided remarks regarding potential ramifications to changing the Charter language. Discussion ensued.

Member Suarez stated there was no way to monitor full or part time positions for the commissioners. Discussion ensued. The committee members agreed to table the full or part time positions discussion.

Chair Douglas announced the committee would not vote on a District or At-Large Commissioner since the committee will not recommend additional commissioners.

Action: The Number and Composition of County Commission Districts Committee approved a motion to not proceed with the consideration of having full time district commissioners.

CRC Attorney Brackins provided an overview of the final report and requested that the committee provide him with the language regarding the basis for their actions. Chair Douglas stated that any additional language to be included in the final report be provided to staff by the end of the following week. Discussion ensued. Chair Douglas recommended an additional meeting that strictly reviews the final report. Discussion ensued.
