AN ORDINANCE PERTAINING TO LAND USE IN ORANGE COUNTY, FLORIDA; AMENDING CHAPTER 38 ("ZONING") OF THE ORANGE COUNTY CODE; AMENDING SECTION 38-1 TO CREATE A DEFINITION FOR MOBILE TEMPORARY OVERNIGHT SHELTER (MTOS); AMENDING THE ZONING DISTRICT USE TABLE TO ESTABLISH MOBILE TEMPORARY OVERNIGHT SHELTERS AS A LAND USE; CREATING SUBSECTION 38-79(7) TO ESTABLISH OPERATIONAL STANDARDS FOR MOBILE TEMPORARY OVERNIGHT SHELTERS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.
