### **RECOMMENDATION:**

Selection of Drummond Carpenter, PLLC, Environmental Research & Design, Inc., Geosyntec Consultants, Inc., and WSP Environment and Infrastructure, Inc. to provide Continuing Water Quality Professional Services, Request for Proposals Y23-905-MB.

Request Board authorization for the Procurement Division to negotiate and execute final contracts to establish hourly rates for future requirements for an initial one-year term with two one-year renewals.

The Procurement Committee evaluated the proposals on November 1, 2023. Commissioner Maribel Gomez Cordero was assigned to the Procurement Committee.

#### **PURPOSE:**

The contracts will provide continuing professional services to implement water quality projects throughout Orange County. Services under the contracts will include conducting assessments, feasibility studies, performance monitoring, and technical support projects. Assessments will characterize and evaluate current water quality, hydrologic conditions, and nutrient pollutant sources of a water body, in addition to developing and recommending a set of ranked structural and non-structural best management practice projects intended to restore or maintain the water quality of the water body. Feasibility studies will evaluate the constructability and cost effectiveness, potential permitting, ecological, and construction-related issues associated with potential projects. Performance Monitoring will verify pollutant removal efficiency of projects for regulatory program reporting and in order to make educated decisions as to their use in the future. Four contracts are necessary to facilitate the anticipated increase in the quantity of assessments, feasibility studies, and performance monitoring projects and their accompanying labor and analytical resource requirements.

#### DISCUSSION:

Four proposals were received in response to this Request for Proposals (RFP). The Procurement Committee evaluated the proposals in accordance with the criteria set forth in the RFP.

The consensus scores of the Procurement Committee are attached.
