COVID-19 Statistics

COVID-19 Cases in Orange County

- Over 118,713 cumulative cases
- 1,169 deaths
- 14 days' average positivity rate is approximately 5.1%
- Vaccines continue to provide a positive impact

COVID-19 Testing

- Convention Center, Barnett Park
- Averaging 2,000 tests per day
- Barnett Park site will remain open through March 31, 2021



COVID-19 Statistics

COVID-19 Vaccinations

- **Over 367,948 doses administered in Orange County**
- **Over 131,777 Orange County seniors (60+) have been vaccinated (58.3% of senior population)**
- **20.5% of Orange County residents (18+) have been vaccinated**



COVID-19 Statistics

COVID-19 Vaccination Initiatives

- **Orange County eligibility**
 - 40+ years old
 - Educators, Law Enforcement and Firefighters of all ages
 - Child care providers
 - High risk patients with physician authorization

- **Orange County Convention Center**
 - 3,400 doses per day, 6 days a week

- **OCFRD initiatives**
 - Extensive support to Convention Center site
 - Senior living communities – 21 communities visited
 - Approximately 7,000 vaccinations
 - Homebound vaccine initiative began March 1, 2021



COVID-19 Statistics

COVID-19 Vaccination Initiatives

▪ **FEMA Sites**

- Valencia College – West Campus
- Averaging over 2,000 vaccinations per day

▪ **Community Spoke sites**

- Availability for 500 vaccinations per day
 - Englewood Community Center
 - Kelly Park
 - Econ Park
 - Barnett Park
 - Northwest Neighborhood Center
 - South Econ Youth Sports Complex

▪ **South Orange Trail Library**

- Availability for 200+ vaccinations per day

Emergency Rental Assistance Program

- **Total Applicants in Portal – 3,933**
- **Total Applicants Submitted – 1,695**
- **Total applications under review – 1,168**
 - **Applicants who have been contacted – 775**
- **Total Approved – 40**
- **Total Denied - *350**
- ***Most of the denials are for duplication and/or for residents who do not qualify because they live in the City of Orlando or outside of Orange County.**



Emergency Rental Assistance Program

System and Processing

- The rollout is still strong and there are no issues with the software or capacity.
- Applications have been streamlined and are easier to complete.
 - Staff are reaching out to applicants to request missing information and documentation.
 - Applicants are able to log into the system to check their status.
- Treasury continues to provide updated guidance.
