# Subject:

Ordinance No. 2021-70 Street Name Changes, from Sylvia Lane to Boone Ave. and from S. Garland Ave. to Sylvia Ln. (District 5)(SNC2021-10002) (Economic Development)

# Summary:

Ordinance No. 2021-70 will rename two (2) street segments in the Central Business District extending into the South Orange neighborhood, as follows:

A. From Sylvia Ln. to Boone Ave. (between America St. north to the Grace St./Boone Ave. extension); and

B. From S. Garland Ave. to Sylvia Ln. (from the City Commons garage south to the /Grace St./Boone Ave. extension).

The street name changes are proposed as part of the extension of Boone Ave. south from W. Anderson Street as part of the I-4 Ultimate project and SR408 interchange improvements. The Boone Ave. extension, very nearly complete, will connect to Sylvia Ln. With the proposed street name changes, street signs would be changed to reflect the proposed Boone Ave. street name from W. Anderson St. south to America Street and with S. Garland Ave. signs being replaced with Sylvia Ln. signs from the City Commons garage south to the Boone Ave. extension.

The Municipal Planning Board (MPB) recommended approval of the street name change request on May 18, 2021, and the City Council approved the May 2021 MPB minutes on June 28, 2021. City Council approved the street name changes on 1st reading on October 25, 2021.

WHEREAS, at its regularly scheduled meeting of May 18, 2021, the Municipal Planning Board (the "MPB") of the City of Orlando, Florida, considered an application (City of Orlando case number SNC2021-10002) for the renaming of Sylvia Lane to Boone Avenue between America Street and the Grace Street/Boone Avenue Extension, and the renaming of South Garland Avenue to Sylvia Lane between the City Commons garage and the Grace Street/Boone Avenue Extension; and

WHEREAS, the Mayor directed the Planning Official to prepare an application for a street name change pursuant to the procedures in Section 65.538, Orlando City Code; and

WHEREAS, based upon the evidence presented to the MPB, including the
information and analysis contained in the "Staff Report to the Municipal Planning Board"

51 for street name change application case number SNC2021-10002 (entitled "Sylvia Ln. to 52 Boone Ave. & S. Garland Ave. to Sylvia Ln." and hereinafter referred to as the "staff 53 report"), the MPB recommended that the City Council of the City of Orlando, Florida (the 54 "Orlando City Council"), approve the street name change application and adopt an 55 ordinance in accordance therewith; and

**WHEREAS**, the Orlando City Council hereby finds that this ordinance is in the best interest of the public health, safety, and welfare, and is consistent with the applicable provisions of the Orlando City Code.

# NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF ORLANDO, FLORIDA, AS FOLLOWS:

**SECTION 1. STREET NAME CHANGE.** After due notice and public hearing, and having met all other conditions precedent in accordance with sections 65.537 and 65.538, Orlando City Code, and all other applicable laws, the name of the street segments are hereby changed from "Sylvia Lane" to "Boone Avenue" and from "South Garland Avenue" to "Sylvia Lane," as depicted in **Exhibit A** to this ordinance.

**SECTION 2. AMENDMENT OF OFFICIAL MAPS.** The city clerk, the City planning official, the city engineer, and the City zoning official, or their respective designees, are hereby directed to amend the City's official maps in accordance with this ordinance.

**SECTION 3. SCRIVENER'S ERROR.** The city attorney may correct scrivener's errors found in this ordinance by filing a corrected copy of this ordinance with the city clerk.

**SECTION 4. SEVERABILITY.** If any provision of this ordinance or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are severable.

SECTION 5. EFFECTIVE DATE. This ordinance is effective upon adoption.


