ACTION REQUESTED:

Approval to award Invitation for Bids Y18-1027-AV, Shuttle Bus Services for Orange County Convention Center, to the following low responsive and responsible bidders by Lot, for an estimated contract award amount for a 1-year term. Lot 1, Owl Inc. \$207,000. Lot 2, Luxury Transportation Group Incorporated \$235,700, Colstar Transportation Services Inc. \$249,000, Empire Coach Line, Inc. \$258,430, JB Bus Inc. \$264,300 and Owl, Inc. \$266,500. Lot 3, Owl, Inc. \$114,000 and Luxury Transportation Group Incorporated \$115,900. Further, request authorization for the Procurement Division to renew the contracts for four additional 1-year terms.

PROCUREMENT:

To provide shuttle bus services for events held in the Orange County Convention Center. Services covered by this contract include transportation for employees and events.

FUNDING:

Funding is available in account 4430-035-0985-3197.

APPROVALS:

The Convention Center and Business Development Division concur with this recommendation.

REMARKS:

Eleven bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility and price reasonableness. Maingate Transportation, Phoenix Bus, Inc., Trinity Coach, Inc., Academy Bus, LLC, was deemed non-responsive because they failed to meet the Qualification of Bidders requirements. Express Transportation, Inc. was deemed non-responsive for qualifying their bid with conditions. Empire Coach Line failed to bid an acceptable mini bus size/capacity and therefore did not meet the qualifications for Lot 3 and is deemed non-responsible.

Therefore, recommendation for award is made to the lowest responsive and responsible bidder, for Lot 1, Owl, Inc., for Lot 2, Luxury Transportation Group Incorporated, Colstar Transportation Services Inc, Empire Coach Line, Inc., JB Bus Inc, and Owl, Inc., and for Lot 3, Owl, Inc. and Luxury Transportation Group Incorporated who all meet the requirements of this solicitation.
