The Department of Homeland Security, through the Federal Emergency Management Agency, awarded agreement EMW-2018-FO-05290 to the Orange County Fire Rescue Department (OCFRD) in the amount of \$2,703,590.90, with \$270,359.10 matching non-federal funds for a total amount of \$2,973,950. These funds will be used to administer a comprehensive Safety Officer Certification Program to all Battalion Chiefs, provide Fire Officer Training to 90 Firefighters/Engineers, and provide a Fire Inspector Training Program to 78 Lieutenants. This training will improve firefighter safety, increase supervisor effectiveness, and enhance building safety inspections.

Article 1 Assurances, Administrative Requirements, Cost Principles, Representations and Certifications

The prohibition on disability discrimination includes the requirement that new multifamily housing with four or more dwelling units—i.e., the public and common use areas and individual apartment units (all units in buildings with elevators and ground-floor units in buildings without elevators)—be designed and constructed with certain accessible features. (See 24 C.F.R. Part 100, Subpart D)

Article 10 Copyright

Recipients must affix the applicable copyright notices of 17 U.S.C. §§ 401 or 402 and an acknowledgement of U.S. Government sponsorship (including the award number) to any work first produced under federal financial assistance awards.

Article 11 Debarment and Suspension

Recipients are subject to the non-procurement debarment and suspension regulations implementing Executive Orders (E.O.) 12549 and 12689, and 2 C.F.R. Part 180 as adopted by DHS at 2 C.F.R. Part 3000. These regulations restrict federal financial assistance awards, subawards, and contracts with certain parties that are debarred, suspended, or otherwise excluded from or ineligible for participation in federal assistance programs or activities.

Article 12 Drug-Free Workplace Regulations
