EMSAC's Report and Recommendation on The Nemours Foundation d/b/a Nemours Children's Hospital, Florida's Application for a Certificate of Public

Convenience and Necessity to Provide Interfacility Advanced and Basic Life

Support Transport Services in Orange County, Florida

In April 2024, Orange County's Office of the Medical Director/EMS Division notified Orange County's Emergency Medical Services Advisory Council that The Nemours Foundation d/b/a Nemours Children's Hospital, Florida had applied for a certificate of public convenience and necessity to provide interfacility advanced and basic life support transport services.

Pursuant to Section 20-95 of the Orange County Code, EMSAC met on May 15, 2024, to evaluate the countywide emergency medical services system and review Nemours' application to expand the system by issuing an additional COPCN to provide interfacility advanced and basic life support transport services. At the meeting, EMS framed the issue, Nemours presented its application, and EMSAC heard public comment and deliberated. In determining whether the application was in the interest of the public convenience and necessity, EMSAC considered the guidelines adopted by the Board as codified in Section 20-95 of the Code. Specifically, EMSAC considered: (1) the number of providers currently providing services and the type and quality of services being provided; (2) the historic number of requests for service; (3) the benefits of the proposed service; (4) the results of the most recent County conducted survey; (5) the objection to Nemours' application; and (6) Nemours' application.

At the conclusion of the meeting, EMSAC found that the issuance of an additional COPCN is in the interest of the public convenience and necessity and voted to recommend Nemours' application for approval.

# I. Application.

On March 27, 2024, Orange County EMS received an application from The Nemours Foundation d/b/a Nemours Children's Hospital, Florida for a COPCN to provide interfacility advanced and basic life support transport services in Orange County, Florida ("Application"). In accordance with Section 20-94 of the Orange County Code, EMS reviewed the Application and deemed the Application timely, accurate, and complete. EMS provided reasonable notice of the Application to the relevant parties including Orange County's Emergency Medical Services Advisory Council, the general public, municipalities, and all current COPCN holders. EMS received a written objection to the application from Lifefleet Southeast, Inc., d/b/a American Medical Response. In accordance with Section 20-95 of the Code, EMS scheduled a meeting for EMSAC to evaluate the countywide emergency medical services system to consider the Application to expand the system by issuing a COPCN to Nemours.

### II. EMSAC Meeting on May 15, 2024.

EMSAC met on May 15, 2024, to evaluate the countywide emergency medical services system and review Nemours' application to expand the system by issuing an additional COPCN to provide interfacility advanced and basic life support transport services. At the meeting, EMS framed the issue, Nemours presented its application, and EMSAC heard public comments. In determining whether the application was in the interest of public convenience and necessity, EMSAC considered the guidelines adopted by the Board as codified in Section 20-95 of the Code. Specifically, EMSAC considered: (1) the number of providers currently providing services and the type and quality of services being provided; (2) the historic number of requests for service; (3) the benefits of the proposed service; (4) the results of the most recent County conducted survey; (5) the objection to Nemours' application; and (6) Nemours' application. At the conclusion of the

meeting, EMSAC found that the issuance of an additional COPCN is in the interest of the public convenience and necessity and voted to recommend Nemours' application for approval. Following the meeting, EMSAC submitted its Report and Recommendation to EMS, a copy of which is attached to this Memorandum.

### III. EMS' Recommendation.

Pursuant to Section 20-96 of the Code, EMS recommends that the Board grant The Nemours Foundation d/b/a Nemours Children's Hospital, Florida's application for a certificate of public convenience and necessity to provide interfacility advanced and basic life support transport services in Orange County, Florida. EMS will schedule this item for a future Board agenda and request Board action for the final disposition of the Application.
