I am pleased to present the following four managerial appointments for confirmation. These four professionals bring a vast amount of experience to their new roles and will be outstanding additions to the county's senior management team.

County Administrator's Office

Mr. Randy Singh for Deputy County Administrator, Administration & Fiscal Services

Randy Singh has over 30 years of professional experience in accounting, finance and budget. Mr. Singh began his career as an accountant in New York City in 1987 and joined Orange County in 1995 in the Office of Management and Budget. In 1997, he left briefly for several months accepting a position with LYNX serving as the Manager of Financial Planning and Budgets. He returned to Orange County in 1998 as a Budget Administrator and in 2002 was appointed as the OMB Manager. He served in that role for over 12 years, making him the longest serving OMB Manager. In December of 2014, Randy was appointed the role of Assistant County Administrator overseeing several important areas of the county including: the Family Services Department, the Administrative Services Department, OMB, Office of Economic Trade and Tourism and he also served as the liaison to all of the county constitutional offices and other external agencies.

Mr. Singh holds a Bachelor of Business Administration in Accounting from the City University of New York – Bernard M. Baruch College of Business. He is also a graduate of the New York Institute of Audio Research – Audio Engineer. He is a Certified Public Finance Officer within the United States and Canada and a Certified Government Finance Officer within the State of

Mr. Chris Testerman for Deputy County Administrator, Infrastructure, Community & Development Services

Mr. Testerman began his Orange County career in the Planning Department in 1990 and has held increasingly responsible positions including Manager of the Planning Division for seven years until 2007 when he was appointed to Director of Government Relations. Mr. Testerman will begin his new role as Deputy County Administrator, Infrastructure, Community & Development Services at an annual starting salary of \$191,006.40. Mr. Daniel P. Banks for Deputy County Administrator, Public Safety

Mr. Banks has 25 years of public safety experience and has been employed by the Florida Department of Law Enforcement (FDLE) since 2000. Since 2012, he has served as the Special Agent in Charge at the Orlando Regional Operations Center, where he supervises nine counties in the region and oversees all FDLE's criminal investigations. During his 18-year tenure with FDLE, he served in various leadership roles, including those in special agent investigations for narcotics, money laundering, violent crime and domestic security. He has received numerous accolades at FDLE, including Excellence in Leadership, State Law Enforcement Officer of the Year and Special Agent of the Year. Prior to joining FDLE, Mr. Banks served at the Orange County Sheriff's Office for seven years in various roles.

Mr. Banks holds a Bachelor of Science in Economics from Florida State University. Mr. Louis A. Quiñones, Jr. for Chief of Orange County Corrections

Louis A. Quiñones, Jr. has over 31 years of experience in the field of Corrections, and has been employed with four large agencies in two states. He currently serves as the Deputy Chief of Operational Services at Orange County Corrections where he provides oversight and leadership to over 2,400 inmates and over 1,200 staff members, to include more than 1,000 certified correctional officers. Deputy Chief Louis A. Quiñones, Jr. began his career in corrections in 1987 as a Detention Deputy with the Broward County Sheriff's Office. In 1989, he relocated from Broward County and joined Orange County Corrections as a Correctional Officer where he was promoted through the ranks to Lieutenant in 2007. In 2010, he joined Osceola County Corrections as a Captain. Shortly thereafter, he rejoined Orange County Corrections and retired as a Captain in 2013. In December of 2013, he joined Bexar County Sheriff's Office in San Antonio, Texas as a Deputy Chief, Assistant Jail Administrator. In January of 2017, he assumed the responsibilities of Deputy Chief of Operational Services at Orange County Corrections in Orlando, Florida, where he currently serves. His appointment will become effective upon confirmation.

Deputy Chief Quiñones' holds a Bachelor of Arts, Criminal Justice Administration from Columbia College and a Master of Science, Strategic Leadership from Mountain State University. He is a Certified Corrections Executive (CCE), Certified Jail Manager (CJM), Certified Public Manager (CPM), and a Certified National Auditor with the American Correctional Association (ACA). He currently serves on the Board of Directors of the American Jail Association, National Alliance on Mental Illness, and on the Executive Steering Committee for the Central Florida Informational Exchange.
