Consideration: Collegiate Village Planned Development / Collegiate Village CVC – West Parcel Development Plan submitted in accordance with Article II of Chapter 34 of the Orange County Subdivision Regulations. Rosalind Avenue, Orlando, Florida, Orange County staff will be present to assist at the kiosk in Room 105 and on the First Floor to ensure that social distancing and other health and safety measures are practiced and enforced.
