Applicant: Brooks Stickler, Kimley-Horn & Associates, Inc., East Colonial Student Housing Planned Development / Land Use Plan (PD/LUP), Case # CDR-21-08-260

Consideration: A PD substantial change request to amend the maximum building height waiver to allow all buildings on site to be five (5) stories / sixty (60) feet in height. The requested waiver language is as follows: 1. A waiver from Section 38-1259 (k) to allow all buildings to be a maximum of five (5) stories, sixty (60) feet in height, in lieu of the required three (3) stories, forty (40) feet in height; pursuant to Orange County Code, Chapter 38, Article VIII, Division 1, Section 38-1207 Location: District 5; property generally located on the north side of East Colonial Drive, east of Challenger Parkway; Orange County, Florida (legal property description on file in Planning Division)
