REMARKS:

Four bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The submission from Strong Cap, LLC was deemed non-responsive for failing to submit the required bid documents. Due to the magnitude of work and expanse of areas to be serviced, four contracts are needed. The solicitation established that it was the County's intent to make multiple awards, and then in the event competition was limited, bidders could be awarded more than one lot.

Lakeside Electrical Services, Heron Electric Inc, and Base 3, LLC dba Gibson Electric have a satisfactory record of performance and possess the required licensure to perform the services. Therefore, award is recommended to Lakeside Electrical Services – Lots A and D, Heron Electric Inc. – Lot B, and Base 3, LLC dba Gibson Electric – Lot C.
