ACTION REQUESTED:

Approval to award Invitation for Bids Y20-111-MV, Tree Trimming and Related Services Except Parks and Public Works – Zones 1 and 4, on a zone by zone basis, to the low responsive and responsible bidder, C & C Tree Pros, Inc. in the estimated total contract award amount of \$788,375 for a 1-year term. Further request authorization for the Procurement Division to renew the contract for four additional 1-year terms.

PROCUREMENT:

This contract will support the operations of the Facilities Management Division, Downtown and East Districts Services under this contract include pruning of trees, stump grinding, and the removal of dead, diseased, or undesirable trees from County owned properties.

FUNDING:

Funding is available under 001-043-1716-3810.

APPROVALS:

The Facilities Management and Business Development Divisions concur with this recommendation.

REMARKS:

Five bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The low bidder, C & C Tree Pros, Inc., met the minimum requirements to perform this contract. Core Services, LLC requested to withdraw their bid due to incorrect pricing for bid items. The Procurement Manager approved the request to withdraw. The bid submitted by Advance Tree Pros, LLC was deemed non-responsible due to insufficient references. The bid submitted by Quisqueya Landscaping Services, Inc. was deemed non-responsive for failing to submit a complete bid package.

Advanced Tree Pros, LLC filed a timely protest. A protest review was held on November 21, 2019, resulting in a denial of the protest. No appeal was filed.

Zone assignment is made to maximize geographical proximity to allow for effective management.
