### **RECOMMENDATION:**

Selection of one firm and an alternate to provide Design Services for Lake Ellenor Community Park, Request for Proposals Y23-821-MB, from the following firms listed alphabetically:

• AVCON, Inc.

• SK Consortium, Inc.

Further request Board authorization for the Procurement Division to negotiate and execute a contract with a not-to-exceed budget of \$500,000.

Further request authorization for the Procurement Division to formally terminate negotiations with the top ranked firm, if we are unable to come to a favorable negotiated agreement, and commence negotiations with the next ranked alternate, until a successful negotiation is reached.

The proposals were evaluated by the Procurement Committee on August 16, 2023. Commissioner Nicole Wilson was assigned to the Procurement Committee.

#### **PROCUREMENT:**

This contract will provide a community park that will improve the quality of service available to the public. This project consists of approximately 20.01 acres and may include the following amenities such as playground/tot-lot with shade structure, walk and or nature path, picnic pavilions, lighted multipurpose soccer fields, baseball/softball, pickleball courts, concrete sidewalks, landscaping, parking, irrigation, and drainage. In addition, a restroom and concession stand building will be included. This project is located in District 6.
