**Director's Report by Sonya Hill, Manager**

- All staff completed the Gold Standard Customer Service Training to strengthen the program's commitment to provide high quality services to our families.
- Each site hosted an event for Head Start Awareness Month
- Head Start is collaborating with the NHSA in preparation for the Parent & Family Engagement Conference being held in Orlando December 8 – 11, 2025
- OCHS received the State Corporate Award from the FHSA for its partnership with A Gift for Teaching
- There was a \$10,769.80 savings in food waste compared to the same quarter last year.
- Office relocations are under way at the main office that will enhance workflow and supervision, confidentiality for sensitive conversations with families and increase staff morale and professionalism.
- The Government shutdown impacted OCHS resulting in the program being operated using county funds.
