ACTION REQUESTED:

Approval of commercial refuse license for Let's Move Florida LLC dba College Hunks Hauling Junk to provide solid waste hauling services to commercial generators in Orange County for a five-year term. All Districts. (Solid Waste Division)

PURPOSE: The Solid Waste Division has received a commercial refuse license application from Let's Move Florida LLC dba College Hunks Hauling Junk, to provide solid waste hauling services to multi-family generators in Orange County.
