SILVERLEAF ROAD NETWORK AGREEMENT C.R. 545/AVALON ROAD AND NEW INDEPENDENCE PARKWAY

THIS FIRST AMENDMENT TO AMENDED AND RESTATED SILVERLEAF ROAD NETWORK AGREEMENT (the "First Amendment"), is effective as of the last date of execution by the parties hereto (the "Effective Date"), and is made and entered into by and between JEN FLORIDA 36, LLC, a Florida limited liability company ("Jen Florida"), HAMLIN PARTNERS AT SILVERLEAF, LLC, a Florida limited liability company ("Hamlin Partners") and ORANGE COUNTY, a charter county and political subdivision of the State of Florida, whose mailing address is P.O. Box 1393, 201 S. Rosalind Avenue, Orlando, Florida 32802-1393 ("County").

WITNESSETH:

WHEREAS, Jen Florida, Hamlin Partners and County (collectively the "Parties") are parties to that certain Amended and Restated Silverleaf Road Network Agreement recorded April 1, 2025 at Doc# 20250188632, Public Records of Orange County, Florida (the "Silverleaf Road Agreement"); and

WHEREAS, the Parties desire to amend the Silverleaf Road Agreement pursuant to the terms of this First Amendment.

NOW THEREFORE, for and in consideration of the above premises, the mutual covenants and agreements set forth herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree to amend the Silverleaf Road Agreement as follows:

- 1. Recitals. The foregoing recitals are true and correct and are incorporated herein by reference. All capitalized terms not otherwise defined in this First Amendment shall have the meanings ascribed to them in the Silverleaf Road Agreement.
- 2. <u>Deletion of Letter of Credit Requirement</u>. Paragraph 5.2 of the Silverleaf Road Agreement is hereby amended by deleting the former subsection 5.2(iv) requiring an irrevocable letter of credit. The amended Section 5.2 is hereby restated to read as follows:
- "5.2 <u>Construction</u>. Prior to construction of any Improvements, Constructing Owner shall (i) obtain all applicable permits and final County construction plan approval,

and (ii) provide satisfactory payment and performance bonds in the amount of the Improvement construction contracts, together with a rider to such bonds identifying County as a dual-obligee.

Upon completion of any segment of roadway construction, County shall issue a certificate of completion (including but not limited to, the following listed items), to Construction Owner within ten (10) business days after receipt by County of (i) the engineer's certification of completion, (ii) acceptable as-built drawings and (iii) all other applicable deliverables as shown on the certificate of completion form."

3. <u>Ratification</u>. Other than as set forth in this First Amendment, the Silverleaf Road Agreement shall remain unchanged and in full force and effect.
