RESOLUTION 2025-05

A RESOLUTION OF THE CITY OF TAVARES, FLORIDA, GRANTING VARIANCES TO THE CITY OF TAVARES LAND DEVELOPMENT REGULATIONS FOR THE MINIMUM SIDE AND REAR YARD SETBACKS IN A COMMERCIAL DOWNTOWN DISTRICT (CD) ZONING FOR PROPERTY LOCATED AT 122 EAST MAIN STREET; SUBJECT TO THE RULES, REGULATIONS AND OBLIGATIONS ORDAINED BY THE CITY OF TAVARES COUNCIL; PROVIDING AN EFFECTIVE DATE.
