November 29, 2016 - Consent Item Environmental Protection Commission Recommendation for a Variance Request for the Huff Dock Construction Permit BD-16-07-084

On July 27, 2016, the Environmental Protection Division (EPD) received an Application to Construct a Dock for the referenced property. The Applicant proposes to add a covered boathouse to an existing pier; therefore, the entire structure must meet the current Dock Construction Code.

The existing structure is constructed with a floor elevation of 58.29 NGVD (1929); it does not meet the minimum floor elevation of one (1) foot above the Normal High Water Elevation (NHWE). Therefore, in an effort to allow the structure to remain as constructed, and add a covered boat slip, the Applicant provided an application for Variance to Section 15-342(d) on August 23, 2016.

Per the Orange County Lake Index, the NHWE of Lake Georgia is established at 59.50 feet NGVD (1988). Review of historical lake level data for this lake indicates that the NHWE has not been reached since April 1961.

During the August 31, 2016 public hearing, the Environmental Protection Commission (EPC) voted to uphold the recommendation of the Environmental Protection Officer (EPO) and approve the request for variance to Section 15-342(d) floor elevation.

ACTION REQUESTED: Acceptance of the Recommendation of the Environmental Protection Commission to uphold the Environmental Protection Officer's recommendation of approval of a Variance to Orange County Code, Chapter 15, Article IX, Section 15-342(d) for the Huff Dock Construction Permit BD-16-07-084, with the condition that the applicant enter into a Hold Harmless and Indemnification Agreement with Orange County for the Dock being constructed below the Normal High Water Elevation. District 5

SUBJECT: Huff Boat Dock Construction Variance Request

### **Reason For Public Hearing**

The applicant, Richard Huff, is requesting a variance from Orange County Code, Chapter 15, Article IX, Section 15-342(d)(floor elevation).

#### Location of Property

The project site is located at 9945 Lake Georgia Drive, Orlando, on Lake Georgia. The Parcel ID is 06-22-31-0000-00-073. The subject property is located in Orange County Commission District 5.

#### **Public Hearing Notifications**

The applicant, agent, and owners of the shoreline properties situated within 300 feet of the property on which the proposed dock is located were notified of the request for variance on September 8, 2016.

### **Staff Findings**

On July 27, 2016, the Environmental Protection Division (EPD) received an Application to Construct a Dock for the referenced property. There is an existing unpermitted dock that was built prior to December 19, 1988, and is therefore considered a grandfathered structure; however, the pending application includes the addition of a covered boat house at the end of the existing dock. Therefore, the structure must meet the current Dock Construction Code.

Per the Orange County Lake Index, the Normal High Water Elevation (NHWE) of Lake Georgia is 59.50 feet NGVD (1929)/ 58.41 NAVD (1988) and a review of lake level data indicates that the NHWE has not been reached since April 1961.

The current dock is constructed with a floor elevation of 58.29 feet NGVD (1929); it does not meet the minimum floor elevation of one (1) foot above the NHWE. Therefore, in an effort to allow the structure to remain as constructed and add a covered boat slip, the Applicant provided an application for variance to Section 15-342(d) on August 23, 2016.

Pursuant to Section 15-350(a)(1), Variance...the applicant shall describe how strict compliance with the provisions from which a variance is sought would impose a unique and unnecessary hardship on the applicant – the hardship cannot be self-imposed; and (2) the effect of the proposed variance on abutting shoreline owners.

To address Section 15-350(a)(1)(1) the applicant has stated that, "the NHWE is unrealistically high for Lake Georgia. The existing dock is four feet above the water which is two feet below the NHWE. It has never come close to going underwater." To address Section 15-350(a)(1)(2) the applicant shall describe the effect of the proposed variance on abutting shoreline owners and has stated that, "the abutting shoreline owners will have an even better view of the lake." EPD has received no objections to the variance request.

Included as attachments with this staff report are location map, variance request, site plans, and photos.

#### **Enforcement** Action

There currently is no enforcement action for this property.

#### Staff Recommendation

Although the Applicant has not clearly demonstrated that the hardship is not self-imposed, he believes there is a unique hardship to accommodate the requirement in the Code to have the floor elevation of the dock no more than one foot above the NHWE. It was determined that this will not negatively impact the environment and there have been no objections to the variance request. Therefore, the recommendation of the Environmental Protection Officer is to approve the request for variance to Section 15-342(d) floor elevation, with the condition that the Applicant enter into a Hold Harmless and Indemnification Agreement with Orange County for building a structure below the NHWE.

The abutting shoreline owners will have an even better view of the lake ....



The environmental protection officer, environmental protection commission and the Board of County Commissioners may require additional information necessary to carry out the purposes of this article.




