Office of the Medical Director Division/Health Services Department

On September 21, 2017, the Board of County Commissioners approved an estimated budget for Emergency Medical Services (EMS) in the amount of \$200,685. The Florida Department of Health awarded the grant in the amount of \$210,538, an increase of \$9,853. In addition, interest of \$2,370 and carry-over funds from the previous fiscal year of \$40,858 were awarded for a total grant award of \$253,766. A budget amendment is needed in the amount of \$12,223 for the grant term December 8, 2017 through November 30, 2018.

Therefore, in accordance with Section 129.06(2)(d), Florida Statutes, it is recommended that the following accounts be adjusted by the amounts shown.
