ORDINANCE: **AN ORDINANCE OF ORANGE COUNTY, FLORIDA REPEALING CHAPTER 31.5 TITLED THE ORANGE COUNTY SIGN ORDINANCE; MARKING CHAPTER 31.5 "RESERVED"; AND PROVIDING AN EFFECTIVE DATE.**

APPLICANT: Planning, Environmental, and Development Services Department

SUBJECT: An Ordinance to repeal Chapter 31.5 of the Orange County Code, titled "The Orange County Sign Ordinance", and mark Chapter 31.5 "Reserved" for future use. This Ordinance will be considered in conjunction with the adoption of Comprehensive Plan Amendment 2023-1-C-CP-1 – An Evaluation and Appraisal-based Amendment updating the "Orange County Comprehensive Plan 2010-2030 - Destination 2030" and renaming it the "Vision 2050: Orange County Comprehensive Plan".

This will be the first of two public hearings at which the Board will consider the adoption of the Ordinance

repealing Chapter 31.5 and marking this Chapter "Reserved" for future use. The final public hearing will be held on June 3, 2025, at 5:01 PM, following the 2:00 PM adoption public hearing for the "Vision 2050: Orange County Comprehensive Plan".
