### RECOMMENDATION:

Selection of Big City Catering, Inc. to provide Management and Operation of Cypress Grove and Guest House for Weddings, Corporate Events and Other Occasions, Request for Proposals, Y22-153-AV.

Request authority for the Procurement Division to negotiate and execute a contract with a total estimated revenue of \$672,000 for a three-year term. Further request authorization to renew the contract for two additional one-year terms.

The proposal was evaluated by the Procurement Committee on March 30, 2022. Commissioner Christine Moore was assigned to the Procurement Committee.

#### PURPOSE:

This contract provides revenue, management, and operation of the Cypress Grove and Guest House.

#### REMARKS:

Two proposals were received in response to this Request for Proposals (RFP). It is projected that revenue collected for the renewal terms to be approximately \$144,000 for year four and \$120,000 for year five.
