Consideration: Request for variances in the R-1A zoning district as follows: 1) To allow an existing detached accessory structure (carport) in front of the principal structure in lieu of the rear or side. 2) To allow a south front setback of 6 ft. in lieu of 25 ft. for an existing detached accessory structure (carport). 3) To allow a 6 ft. high fence within the clear view triangle. 4) To allow an 8.55 ft. high gate within the clear view triangle.
