REMARKS:

OCPW seeks to acquire certain lands jointly owned by the County and the City of Orlando (City) through Water Conserv II (Conserv II Property) to allow a northerly extension of Hamlin Groves Trail to be constructed as contemplated by the Road Network Agreement (Northerly Extension of Hamlin Groves Trail from New Independence Parkway to Tiny Road) between SLF IV/Boyd Horizon West JV, LLC and the County approved by the Board on February 24, 2015, as amended. The County's interest in the Conserv II Property is controlled by OCU.

The Purchase Agreement and the City Deed provide for the City's conveyance to OCPW of the City's 50% interest in the Conserv II Property. The Memorandum of Understanding and the Notice of Reservation provide for OCU's transfer to OCPW of the 50% interest in the Conserv II Property controlled by OCU.

The First Amendment to Lease Agreement amends the existing lease agreement between the County and the City for Sportsplex Park to exclude from the legal description of the leased lands those lands which are the subject of the City Deed and the Notice of Reservation and which will now be used by OCPW for the Hamlin Groves Trail Northerly Extension (as opposed to by the Parks and Recreation Division for Sportsplex Park).

A portion of the Conserv II Property which is the subject of this action is being acquired by Water Conserv II pursuant to the Interlocal Agreement for Property Exchange and Pond Reconfiguration Regarding the State Road 429 Ponds (Hamlin Groves Trail Northerly Extension/Park Access Road) (ILA) among the County, the City, and the Central Florida Expressway Authority (CFX) approved by the Board on November 3, 2015, which ILA was the subject of further action of the Board on October 30, 2018. Closing of the Purchase Agreement and the Memorandum of Understanding, and recording of the City Deed and the Notice of Reservation, will occur after closing of the ILA.

PURCHASE AGREEMENT

COUNTY OF ORANGE STATE OF FLORIDA

THIS Purchase Agreement (the "Agreement"), effective as of the latest date of execution (the "Effective Date") is made by and between the CITY OF ORLANDO, a Florida municipal corporation, as to its undivided 50% interest, hereinafter referred to as SELLER, and ORANGE COUNTY, a charter county and political subdivision of the state of Florida, hereinafter referred to as BUYER.

WITNESSETH:

WHEREAS, BUYER and SELLER each owns a fifty percent (50%) undivided interest in land commonly known as Conserv II (the "Property"); and

WHEREAS, in 2007, SELLER leased to BUYER the SELLER'S interest in certain Conserv II land for Buyer's use and for the purpose of planning, designing, permitting, and constructing, one or more public recreational complexes in west Orange County known as the "Sportsplex Park"; and

WHEREAS, a public access road, currently known as the Hamlin Groves Trail northerly extension (the "Park Access Road"), will be constructed to provide accessibility to the Sportsplex Park; and

WHEREAS, in order to accommodate the planned alignment of the Park Access Road, the BUYER wishes to purchase the portion of the Property described on Exhibit "A" attached hereto ("Purchase Property"); and

WHEREAS, SELLER agrees to sell and convey its interest in the Purchase Property by City Deed to BUYER, to wit:

NOW, THEREFORE, in consideration of the sum of one dollar (\$1.00) paid by BUYER to SELLER and the mutual promises contained herein, the receipt and sufficiency of which are hereby acknowledged by each party to the other, the parties agree as follows:

- 1. Conveyance of Property: SELLER agrees to sell and convey to BUYER by City Deed, and BUYER agrees to buy from SELLER, SELLER's fifty percent (50%) undivided interest in the Property identified in Exhibit "A," attached hereto, for the total sum of \$493,250.00.
- 2. Closing: This transaction shall be closed and the deed and other closing papers delivered on or before ninety (90) days from the Effective Date of this Agreement. Closing shall take place at the office of the Orange County Real Estate Management Division, 400 E. South Street, Fifth Floor, Orlando, Florida 32801, or at such place as shall be mutually agreed upon by BUYER and SELLER. BUYER shall pay all recording fees, expenses, taxes, and costs associated with the sale and conveyance of the Property.
- 3. Attorney Fees: Both parties expressly agree that each party shall bear the cost of its own attorney fees and costs for any action arising out of or in connection with this Agreement.
- 4. Condition Precedent. The parties acknowledge that the obligations expressed herein are expressly conditioned upon BUYER'S final approval of the following additional agreements related to the Park Access Roadway alignment:
 - a. Interlocal Agreement among BUYER, SELLER, and the Central Florida Expressway Authority related to pond property exchange and reconfiguration;
 - b. Amendment to Sportsplex Lease Agreement between BUYER and SELLER; and
 - c. Road Network Agreement between BUYER and SLF IV/Boyd Horizon West JV, LLC.
- 5. This Agreement supersedes all previous agreements or representations, either verbal or written, heretofore in effect between SELLER and BUYER, made with respect to the matters herein contained, and when duly executed constitute the Agreement between SELLER and BUYER. No additions, alterations, or variations to the terms of this Agreement shall be valid, nor can provisions of this Agreement be waived by either party unless expressly set forth in writing and duly executed with the same formality as this Agreement.







THIS FIRST AMENDMENT TO LEASE AGREEMENT is made and entered into as of the latest date last written below by and between the CITY OF ORLANDO, FLORIDA, a municipal corporation existing by and under the laws of the State of Florida ("City") and ORANGE COUNTY, a charter county and political subdivision of the State of Florida ("County").

WITNESSETH:

WHEREAS, City and County each owns an indivisible 50% (fifty percent) fee simple share, as tenants in common, in approximately two hundred twenty (220) acres of real property known as the Water Conserv II Property ("Property"); and

WHEREAS, on August 28, 2007, City and County entered into a Lease Agreement related to Water Conserv II Property for Sportsplex Park with Option to Purchase a Portion Thereof (hereafter "Agreement"); and

WHEREAS, in the Agreement, City leased the City's interest in the Property to County for County's use and for the purpose of planning, designing, permitting, and constructing one or more public recreational complexes in west Orange County (the "Sportsplex Park"); and

WHEREAS, in the Agreement the County committed to use some or all of the Property for public park purposes within the first twenty (20) years of the effective date of the Agreement; and

WHEREAS, the County is proceeding to use all or some of the Property for public park purposes, including, as defined in the Agreement, a Park Access Road (currently known as the Hamlin Groves Trail northerly extension) to provide accessibility to the Sportsplex Park, and must adjust the boundaries of the Sportsplex Park to accommodate this roadway; and

WHEREAS, to accommodate the Park Access Road alignment, the parties now agree to amend the configuration of the Property and the legal description as provided in the Agreement.

NOW, THEREFORE, in consideration of TEN DOLLARS (\$10.00) and other good and valuable consideration, the above premises, and the mutual covenants and promises hereinafter contained, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

- 1. The above recitals are incorporated herein by reference.
- 2. Exhibit A of the Agreement shall be deleted and replaced with the new Exhibit A which is attached as Exhibit A to this First Amendment.
- 3. Except as to the modification of Exhibit A, all remaining terms and conditions of the Agreement shall remain in full force and effect.
- 4. The parties acknowledge that the obligations expressed herein are expressly conditioned upon County's final approval of the following additional agreements related to the Park Access Road:
 - a. Interlocal Agreement among County, City, and the Central Florida Expressway Authority related to pond property exchange and reconfiguration;
 - b. Purchase Agreement between County and City for Conserv II land for the Park Access Road and public right-of-way; and
 - c. Road Network Agreement between County and SLF IV/Boyd Horizon West JV, LLC.

MEMORANDUM OF UNDERSTANDING BETWEEN ORANGE COUNTY PUBLIC WORKS DEPARTMENT (OCPW) AND ORANGE COUNTY UTILITIES DEPARTMENT (OCU) FOR REAL ESTATE TRANSFER RELATED TO THE HAMLIN GROVES TRAIL NORTHERLY EXTENSION

THIS MEMORANDUM OF UNDERSTANDING ("MOU"), effective as of the latest date of execution, is made and entered into by and between the ORANGE COUNTY PUBLIC WORKS DEPARTMENT ("OCPW") and the ORANGE COUNTY UTILITIES DEPARTMENT ("OCU").

RECITALS:

WHEREAS, Orange County, Florida owns a fifty percent (50%) interest in three parcels of property in Orange County (Conserv II land) identified as Tax ID Nos. 09-23-27-0000-00-006, 16-23-27-0000-00-009, and 16-23-27-0000-00-021, incorporated by reference and made a part of this MOU (the "Property"); and

WHEREAS, in 2007, Orange County leased certain Conserv II land for purposes of planning, designing, permitting, and constructing one or more public recreational complexes in west Orange County known as the "Sportsplex Park"; and

WHEREAS, a public access road, currently known as the Hamlin Groves Trail northerly extension (the "Park Access Road"), will be constructed to provide accessibility to the Sportsplex Park; and

WHEREAS, in order to accommodate the planned alignment of the Park Access Road, OCPW wishes to acquire the portion of the Property described on Exhibit "'A" attached hereto and incorporated herein ("Park Access Road Property"); and

WHEREAS, as compensation for the Park Access Road Property, OCPW will deposit \$178,250.00 into an account designated by OCU; and

WHEREAS, OCU and OCPW agree that the aforementioned real estate transaction is necessary and appropriate to accomplish the transfer of the controlling rights of the Park Access Road Property from OCU to OCPW so that the Park Access Road Property may be put to more efficient use.

NOW, THEREFORE, for and in consideration of the reciprocal covenants contained herein, OCU and OCPW hereby agree as follows:

- 1. The foregoing recitals are declared to be true and correct and are incorporated into this MOU.
- 2. Once OCPW deposits \$178,250.00 into Accounting Line No. 4420-038-1300-6410, the Controlling Agency for the Park Access Road Property described herein shall transfer from OCU to OCPW. OCU and OCPW acknowledge that this exchange is necessary to adequately serve nearby properties.






