## **RECOMMENDATION:**

Selection of one firm and two ranked alternates to provide an Arts and Cultural Master Plan, Request for Proposals Y23-604-JA, from the following firms listed alphabetically:

- AEA Consulting, LLC
- DVDL Design Decisions Inc
- The Cultural Planning Group, LLC

Request Board authorization for the Procurement Division to negotiate and execute a contract within a budget of \$285,000. Further request Board authorization for the Procurement Division to formally terminate negotiations with the top ranked firm, if we are unable to come to a favorable negotiated agreement, and commence negotiations with the next ranked alternate, until a successful negotiation is reached.

Proposals were evaluated by the Procurement Committee on November 8, 2023. Commissioner Maribel Gomez Cordero was assigned to the Procurement Committee.

### PROCUREMENT:

The firm shall create a comprehensive cultural master plan that will focus on several elements to include, but not limited to, private and public arts assets including physical (2D and 3D), performing, visual, literary, and media tech arts, and how to contribute to the cultural arts ecosystem in Orange County, downtown Orlando, and City Main Streets; public arts assets, including performing and visual arts and how they support creative placemaking; and building a local and regional framework for arts funding, through strategic partnerships, with a focus on establishing sustainable and equitable private philanthropy.
