CITIZENS RIGHT TO KNOW ACT PRETRIAL RELEASE PROGRAM REPORT January 2024 – December 2024

BACKGROUND

The Orange County Corrections Department (OCCD) has a long history of operating both a Pretrial Services program and a Pretrial Supervision program. This is the Department's sixteenth annual report.

The Pretrial Services program conducts investigations of pretrial detainees, provides information to the judiciary at first appearance court, releases inmates into the Pretrial Release Supervision program and completes identification and DNA processing of inmates. The Pretrial Supervision program provides community supervision of pretrial detainees and conducts drug-testing for non-supervised offenders. Combined, these two programs constitute a Pretrial Release program (PTR) under Florida State statute.

Section 907.043, Florida Statutes, which is part of the Citizens Right to Know Act, provides that no later than March 31st of every year, each pretrial release program in the State must submit an annual report for the previous calendar year to the governing body and to the clerk of the circuit court in the county where the pretrial release program is located. The statute is specific in the information that must be included and is attached to the annual report.

That same statute defines a pretrial release program (PTR) as an entity, public or private, that:

- conducts investigations of pretrial detainees.
- makes pretrial release recommendations to a court.
- electronically monitors and supervises pretrial defendants.

Legal Authority

Article I Section 14 of the Florida Constitution provides that:

"Unless charged with a capital offense or an offense punishable by life imprisonment, every person charged with a crime or violation of municipal or county ordinance shall be entitled to pretrial release on reasonable conditions".

Section 907.041(3), Florida Statutes, states that "it is the intent of the Legislature to create a presumption in favor of release on nonmonetary conditions".

Pretrial Release (PTR) Program Description

Pretrial Services Unit

The Orange County Corrections Pretrial Services program operates from the Booking and Release Center (BRC) twenty-four (24) hours per day, seven (7) days per week, including weekends and holidays.

Duties performed by this unit include:

- Confirm each inmate's identification through the Florida Department of Law Enforcement (FDLE) based on the Automated Fingerprint Identification System (AFIS).
- Identify and process eligible inmates for Release on Recognizance (ROR) in accordance with the judicial administrative order.
- Screen and research inmate's criminal histories, identify inmates who are sex offenders/predators, out on monetary or non-monetary bond, community control and probation.
- Complete intake interviews, conduct risk assessments, and collect information related to residence, family situation, education, employment, financial status, character, mental health and substance abuse.
- Investigate and verify inmate community ties for the judiciary at first appearance court. Provide First Appearance Fact Sheets to the judiciary, State and Public Defender representatives to assist in making informed detention, release and bail decisions.
- Identify inmates who are homeless or require housing assistance for the Reentry Assistance Initiative.
- Evaluate the pretrial jail population to identify defendants who qualify for community supervision in lieu of incarceration.
- Collaborate with Health Services staff to identify and refer inmates who qualify for the Mental Health Diversion program.
- Identify inmate risk level to assist in assigning to appropriate pretrial supervision program.
- Process court-ordered releases to the Pretrial Supervision program.
- Process inmate fingerprints via RAPID ID and complete the FDLE DNA Sample Submission form for inmates who require DNA processing (this is then forwarded to Corrections Security Intake Officers for DNA collection).

Pretrial Release (PTR) Program Description (cont.)

Pretrial Supervision Unit

The Pretrial Release Supervision Unit operates five (5) days per week and provides supervision of offenders through telephone reporting and office contacts, with supervision level based on the risk level and the conditions ordered by the court. The court's order determines whether offenders are released to Pretrial Release Supervision and under what conditions. The goal is to monitor offender compliance with court-ordered conditions and ensure attendance at all required court hearings.

- A total of <u>2,543</u> individuals were released to Pretrial Release Supervision during calendar year 2024.
- Posting of a monetary bond was required as a condition of the release for <u>41%</u> of offenders.
- The program attained a successful completion rate of <u>88%</u>.

Definition of Success Rate

A pretrial supervised defendant is successful if they appear for all scheduled court appearances and are not charged with a new offense.

For pretrial supervised defendants with closure dates in the same time period, the success rate is calculated by dividing the number of defendants who successfully closed their case by the total number of defendants who closed their case. The rate is usually written as a percentage.
