The Florida Department of Transportation (FDOT) is requesting a time extension to Joint Participation Agreement (JPA) No. 243844-1-78-03 with Orange County to support the National Pollutant Discharge Elimination System (NPDES) permit requirements within the County.

The JPA was approved by the Board on January 28, 2020. Under the JPA, the County receives reimbursement from the FDOT for maintenance of the Orange County Water Atlas and water quality monitoring required by the NPDES permit of which the FDOT is a co-permittee. The FDOT is requesting a time extension from October 31, 2024 to October 31, 2025. This time extension will allow for FDOT to submit a final invoice for the last year of the agreement at the end of Orange County's fiscal year.

The request for time extension was reviewed and approved as to form by the County Attorney's office.
