REMARKS:

Ten bids were received in response to the Invitation for Bids and were evaluated for price, responsiveness, and responsibility. The bid is considered reasonable based on the technical evaluation and recommendation of staff. Silva's Painting and General Services, LLC has a satisfactory record of performance with the County under prior contracts and meets all the requirements of the solicitation.
