#### SECOND MODIFICATION OF EASEMENTS

THIS SECOND MODIFICATION OF EASEMENTS is made and entered into as of the last date signed below by and between **D.R. HORTON**, INC., a Delaware corporation ("DRH") and **ORANGE COUNTY**, a charter county and political subdivision of the State of Florida ("COUNTY").

#### WITNESSETH:

WHEREAS, COUNTY obtained certain easement interests from Austin Groves, Inc., by virtue of that certain Order of Taking ("OT") dated as of July 19, 1985 and recorded July 22, 1985 in Official Records Book 3666, Page 931, and as confirmed by that certain Stipulated Final Judgment ("Judgment") dated as of September 5, 1985 and recorded September 5, 1985 in Official Records Book 3685, Page 2123 of the Public Records of Orange County, Florida (the "Easements"); and

WHEREAS, COUNTY and DRH agreed to modify the area of the Easements and filed that certain Modification of Easements (the "First Modification") dated as of September 11, 2018 and recorded September 14, 2018 as Document No. 20180546070, of the Public Records of Orange County, Florida; and

WHEREAS, DRH remains the fee simple owner and successor in interest of the area encumbered by the easement interests referenced above; and

WHEREAS, subsequent to the recording of the First Modification, an error was discovered in one of the Exhibit "A" sketches of description attached to said First Modification; and

WHEREAS, DRH and COUNTY wish to modify the First Modification for the purposes of correcting the sketches of description of the area of the Easements as set forth herein;

NOW, THEREFORE, in consideration of the mutual covenants and conditions herein contained, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto covenant and agree as follows:

- 1. Recitals. The foregoing recitals are true and correct and are incorporated herein by reference.
- 2. <u>Correction of Easement Areas.</u> Exhibit "A" to the First Modification is hereby deleted in its entirety and replaced with Exhibit "A" to this Second Modification of Easements.
