The Orange County Sheriff's Office is requesting \$139,600 from the FY 2021 Law Enforcement Trust Fund-Federal Forfeitures for the following purpose:

**Rapid ID Scanners – \$139,600.** The purchase of 80 Rapid ID scanners to be used by the Uniform Patrol Division. These scanners will allow deputies to determine if a person with fingerprints on record has provided a false identity, criminal history, or is wanted for a crime.

**ACTION REQUESTED: Approval for the Orange County Sheriff's Office to spend \$139,600 from the FY 2021 Law Enforcement Trust Fund-Federal Forfeitures for Rapid ID Scanners.**

SUBJECT: Federal Forfeiture Fund Request

Please develop a trust fund request for \$139,600 to purchase 80 Rapid ID Scanners.

The purchase of these scanners are not a budgeted item and the Uniform Patrol Division's budget has not funds available to purchase them. Using this device, deputies can determine whether a person has provided a false identify, has a criminal history, or is wanted for a crime. Having this information can alert deputies to whether a person with whom they are interacting may pose a danger to the officer.

These new fingerprint scanners have been tested in the field and represent the most cost efficient option to replace the current devices.
