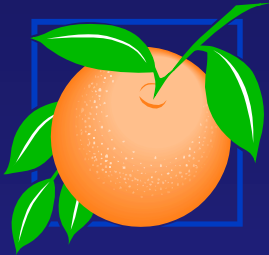

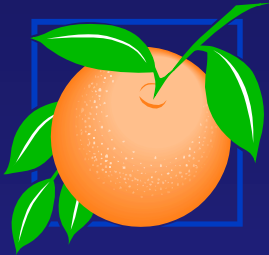

## **Code Enforcement Board**

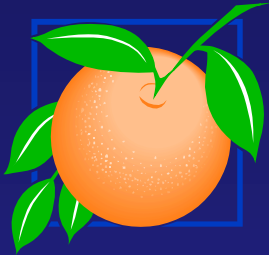
- **Has jurisdiction to hear and decide alleged violations of the codes and ordinances in force in the county**
