PURPOSE:

These contracts will provide continuing engineering design services required for studies, preliminary and final design, permitting, bidding assistance, construction administration, and other services required for completion of projects for improvements to the County's water and wastewater utility systems.

DISCUSSION:

Thirteen proposals were received in response to the Request for Proposals (RFP). The Procurement Committee evaluated the proposals in accordance with the criteria set forth in the RFP. The proposals submitted by Constantine Engineering, Inc, DRMP Inc., EAC Consulting, Inc., and GTC Engineering scored too low for Board consideration.
