The Business Development Division evaluated the two bids submitted for this project and found that at the time of bid opening; at least 22 firms were certified at the sub level in the scope of service. The apparent low bidder Carlson Environmental Consultants, PC did not meet the Orange County M/WBE participation goal of 25%. They reported 0% M/WBE participation in their bid and did not provide good faith effort documentation.

The second low bid submitted by Stearns, Conrad and Schmidt, Consulting Engineers, Inc. did not meet the Orange County M/WBE participation goal of 25%. While they reported \$1,443,296 in M/WBE participation, they did not specify the work to be performed on attachment C-2. Therefore, the M/WBE participation could not be confirmed. They did not provide good faith effort documentation.

Our evaluation of these bids was based on the participation listed on the subcontractor/supplier page.

Attached is a spreadsheet reconciling the bidders' compliance with the IFB's M/WBE requirements, including the percentage breakdown for all bidders and a comparison of the relative bids versus participation percentages.
