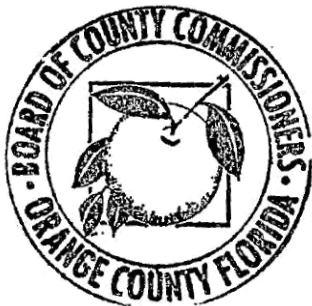
Whereas; the Parties wish to extend the "Agreement" an additional three (3) years, through the 22nd day of April 2028.






