# COVID-19 Statistics

- **Office of Emergency Management Activation**
  - 81 days
- **Orange County COVID-19 cases**
  - 2031 total cases in Orange County
  - 357 total hospitalizations
  - 41 deaths due to COVID-19



# COVID-19 Statistics

- **COVID-19 Testing Sites**
  - **Orange County Convention Center**
  - **Orange County Health Services**
  - **City of Orlando**
  - **Department of Health**
  - **Hospitals and medical facilities**
  - **Private partnerships**
  
- **72344 people tested in Orange County**
  
- **2.8% of tests have been determined positive COVID-19**



# PPE Distribution Initiatives

- **Small Business Recovery PPE (Phase 1)**
  - **May 11-15, 2020**
  - **2.3 million 3-ply masks**
  - **300,000 bottles of hand sanitizer**
  - **15,000 small businesses served**
  
- **Small Business Recovery PPE (Phase 2)**
  - **June 3-4, 2020**
  - **150,000 cloth masks**
  - **100,000 bottles of hand sanitizer**
  - **5,000 small businesses**



# PPE Distribution Initiatives

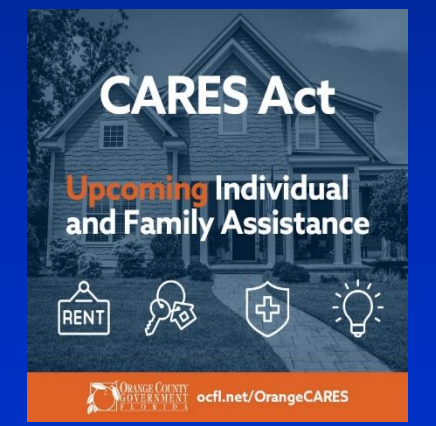
- **Faith-Based Houses of Worship**
  - **May 29, 2020**
  - **400 faith-based organizations served**
  - **350,000 masks distributed**
  
- **Community PPE initiative**
  - **Fire Departments “Leave Behind” initiative**
  - **Health Services COVID-19 testing sites**
  - **One Blood, Second Harvest, OCPS, Homeless Services Network**
  - **Over 300,000 masks and 50,000 bottles of hand sanitizer distributed**

# Small Business Financial Assistance

- The program will offer one-time \$10,000 grants to approximately 6,500 qualifying small businesses
- **Small Business Classification:**
  - **Commercial Business:** Businesses that have a physical commercial location, AND employ 25 employees or less.
    - Mobile businesses that have physical commercial locations are considered commercial businesses for the purposes of eligibility.
  - **Home Businesses:** Businesses with 3-25 employees, not including the owner, that are legally allowed to operate within their jurisdiction, AND have employees that are not residents of the home pursuant to their jurisdiction's zoning regulations.





# Small Business Financial Assistance

## Step 1

## Small Business Eligibility and Documents

### Check for Eligibility

- Verify that you meet the criteria
- Review the Frequently Asked Questions
- Prepare your required documents



- **Verify business meets eligibility requirements**
- **Prepare documents to complete the application**



# Small Business Financial Assistance

## Step 2

### Complete the Application

- Verify business information
- Upload financial and staffing documents
- Fill out the personal information form
- Submit to receive your unique confirmation code



- Business owner completes the application
- Does the application meet all of the requirements and all of the documents are uploaded
  - If YES, application is submitted and business owner receives an email providing ID code and is notified application is headed to review.
  - If NO, the business owner will not be able to submit an application.



# Small Business Financial Assistance

## Step 3



- Internal Orange County team assigns applications to each partner organization for review
  - OEP
  - NCS
  - BBIF
  - Prospera – Spanish Applications
  - Central Florida Foundation
  - City of Orlando
- Application meets criteria and has all of the required documents
  - If YES, application is submitted to Orange County Team for final verification and approval
  - If NO, business owner receives an email notification of denial with an explanation of why it was denied



# Small Business Financial Assistance

## Step 4

### Processing & Distribution

The Orange County Comptroller will process funds for distribution directly to approved businesses.



- Orange County Internal Team sends approved applications to the Comptroller for processing
- Anticipate up to 5 days to process checks

- Application to be online starting Monday, June 8
- Up to 5-10 days business days to review applications
- Up to 5 business days to process checks



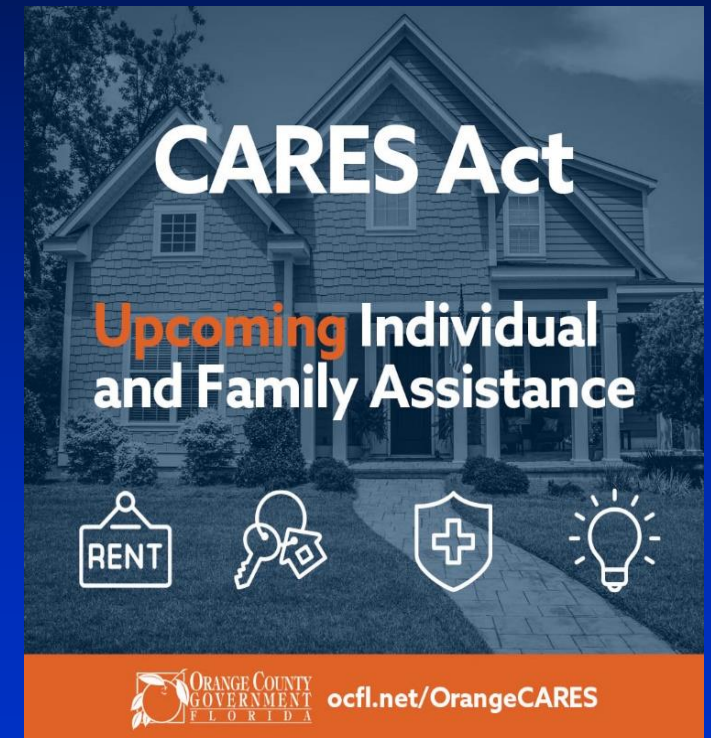


# Social Services and Community Needs

## ▪ Individual and Family Assistance Program

– The program will provide a one-time payment of \$1,000 per household for residents affected by COVID-19.

– Funds for this program will assist residents to bridge financial gaps for overdue rent, mortgage, medical or an eligible utility expense.





# Social Services and Community Needs

## Step 1

### Check for Eligibility

- Verify that you meet the criteria
- Review the Frequently Asked Questions
- Review required documents



### Individual and Family Assistance Eligibility and Documents

- Photo I.D. for all adults in the household (e.g., government issued driver's license, passport, etc.)
- Social Security Cards for all adults in the household
- Unemployment letter, layoff/furlough notice, paystubs to show reduced hours or other document that shows an impact from COVID-19
- Assistance Type Documentation
  - Rental Assistance
  - Mortgage Assistance
  - Medical Bill Assistance
  - Utility Bill Assistance
- Other supporting documents (detailed online)

\* Payments for utility assistance to the Orange County Utilities (OCU) or to the Orlando Utilities Commission (OUC) will NOT be eligible. The U.S. Treasury Department has established this restriction for all government-owned utility companies.



# Social Services and Community Needs

## Step 2

### Complete the Application

- Gather and prepare personal documents
- Fill out initial application and assistance-type forms
- Complete the online application
- Submit to receive your unique confirmation code



- Individual/applicant answers qualifying questions
- Individual/applicant uploads all required documents
- Individual/Applicant completes online application and affirms certification questions
  - If YES, application is submitted and individual receives an email providing ID code and is notified application is headed to review.
  - If NO, individual/applicant receives error message and must correct errors prior to submitting.





# Social Services and Community Needs

## Step 3



- Internal Orange County team reviews applicant's documents for eligibility. Applications will be automatically rejected if any documents are missing, falsified or illegible.
- Applicants will receive an email notifying them as to whether their online application has been approved or denied.

### Notice to Applicant

You will receive an email notification with the status of your application.

Review may take approximately one to two weeks.





# Social Services and Community Needs

## Step 4

### Processing & Distribution

Direct payment will be made to the applicant's service provider, such as property managers or lenders.

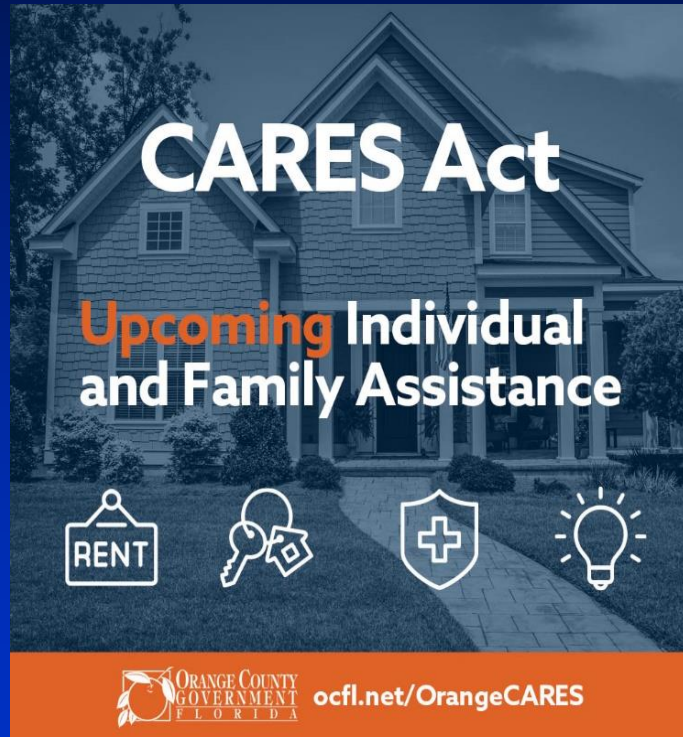
Payment distribution may take approximately two to three weeks, depending on coordination with the service provider.



- Orange County Team sends approved applications to the Comptroller for processing after required documents are received from the vendor.
  - Rent
  - Mortgage
  - Medical
  - Eligible Utility
  
- Anticipate up to 5-10 days to process checks



# Social Services and Community Needs



- Application to be online starting Monday, June 8
- Up to 5-10 business days to review applications
- Up to 5 business days to process checks after required information received from vendor
