Approval to award Invitation for Bids Y24-742-MB, South Water Reclamation Facility North Plant Blower Building and WinCC Upgrade, to the low responsive and responsible bidder, L7 Construction Inc., in the total contract award amount of \$6,232,700.

In the event the bidder recommended above fails to achieve timely compliance with pre-award deliverables, as defined in the Invitation for Bids, including, but not limited to, M/WBE participation sub-contract agreements, State Division of Corporations registration, E-verify, insurance and bonds, further request authorization for the Procurement Division to award to the next low responsive and responsible bidder as listed in the bid tabulation herein, to the extent practicable and advantageous to the County.

PROCUREMENT:

Work under this contract consists of the installation of actuators for air valves to increase blower efficiency and conversion to WinCC programming to match Orange County current utility standard. The project is located in District 6.

The Business Development Division evaluated 2 bids submitted for this project. The Business Development Division completed a M/WBE Availability Analysis. The scope of services for this project had limited M/WBE availability. As a result, the M/WBE goal was reduced from 25% to 8.4%. At the time of bid opening; at least 45 firms were certified to provide the scope of services at the subcontract level.

The apparent low bid, submitted by L7 Construction, Inc., reported 9.11% in M/WBE participation. The apparent low bid met the Orange County M/WBE participation goal per the Ordinance requirement. Please note the following certified M/WBE participation:
