### **AMENDING THE FIRE AND LIFE SAFETY INSPECTION SERVICE FEES CHARGED BY THE ORANGE COUNTY FIRE RESCUE DEPARTMENT**

WHEREAS, Orange County is generally empowered by the Florida Constitution, Florida Statutes, Orange County Charter, and Orange County Code to charge fees for providing a particular governmental service to capture costs associated with the provision of said service; and

WHEREAS, specifically, Chapter 633, Florida Statutes, and Chapter 18, Orange County Code, authorize the Board of County Commissioners to set an inspection service fee in the Orange County Fee Directory and amend said fee from time to time; and

WHEREAS, on June 6, 2023, the Board of County Commissioners adopted Resolution No. 2023-M-20 approving a fee schedule for Fire and Life Safety Inspection Services effective on or after October 1, 2023 (“Schedule of Fees”); and

WHEREAS, the Schedule of Fees was subsequently amended during the County’s budget approval process with the most current Schedule of Fees set forth in the Orange County Fee Directory for Fiscal Year 2024-2025; and

WHEREAS, the Orange County Fire Rescue Department recommends amending the Schedule of Fees to better reflect the actual cost of providing the inspection services; and

WHEREAS, the Orange County Office of Management and Budget concurs with Fire Rescue’s recommendation to amend the Schedule of Fees; and

WHEREAS, the Board wishes to adopt this Resolution to amend the Schedule of Fees, supersede the Schedule of Fees attached to Resolution No. 2023-M-20 as Exhibit A, and replace the Schedule of Fees set forth in the Orange County Fee Directory for Fiscal Year 2024-2025.

**Section 2. Amended Schedule of Fees.** The Board of County Commissioners hereby adopts the amended Schedule of Fees attached to this Resolution as “Exhibit A” with additions shown as underlines and deletions shown as strikethroughs. This amended Schedule of Fees supersedes Exhibit A of Resolution No. 2023-M-20 and replaces the Schedule of Fees set forth in the Orange County Fee Directory for Fiscal Year 2024-2025.

**Section 3. Effective Date.** This Resolution shall become effective upon the date of adoption.

**Fire Rescue**

**Fire and Life Safety Inspection Services**

<b>Fire Safety Inspections:</b>	<b>Cost</b>
Up to and including 2,000 sq. ft. of facility area	\$90.00
Each additional square ft. above 2,000 sq. ft., plus min, not to exceed \$5,000 per building. Includes: State Required Inspections, Licensure Inspections, Requested Inspections, all required inspections, specifically:	<u>\$0.02</u>
<u>Two or more buildings (as that term is defined by the Florida Building Code) under common ownership and subject to a common development permit (as that term is defined in Section 380.031, Florida Statutes) that require Fire Safety Inspections may not exceed \$8,000 in Fire Safety Inspection fees per fiscal year. This limit on fees does not apply to Fire Safety Re-inspections.</u>	
<b>Fire Safety Re-inspections:</b>	
All Re-inspection	<u>\$48.00</u>
<b>Convention, Trade Show, or Exhibit Plans Review and Inspection:</b>	
Review and inspection fee required for items listed below if not included in a permitted convention, show, or exhibit:	
1) Single level exhibit booth or greater than 300 sq. ft. and covered with a ceiling.	
2) Multi-level exhibit booth.	
3) Vehicle, boat, and similar exhibited product having over 1,000 sq. ft. of roofed area.	
4) Motor vehicle brought into an occupancy or building.	
5) Any type of tent erected in an occupancy or building. (If event cannot be inspected due to not being set up during normal business hours, an after-hours inspection will be required at applicant's expense)	<u>\$104.00</u>
