SUBJECT: Approval of Temporary Certificate of Public Convenience and Necessity for Affordable Transport Inc. and Authorization to Schedule a Public Hearing
Consent Agenda – June 18, 2019

The EMS Office of the Medical Director requests the approval of a temporary Certificate of Public Convenience and Necessity (COPCN) to permit Affordable Transport Inc. ("ATI") to continue to provide Interfacility Advanced Life Support Transport Services. This temporary COPCN, valid from July 1, 2019 through September 5, 2019, is sought to allow time for a public hearing and decision on ATI's application for a permanent, standard COPCN, which was filed on April 23, 2019, pursuant to Section 20-94(2), Orange County Code.

The EMS Office of the Medical Director also requests authorization to schedule the public hearing to consider ATI's permanent COPCN application.
