RECOMMENDATION:

Selection of one firm and two ranked alternates to provide Audit Services, Request for Proposals Y21-117-AH, from the following firms listed alphabetically:

Carr, Riggs & Ingram, LLC Cherry Bekaert LLP CliftonLarsonAllen LLP MSL, P.A.

Request authorization for the Procurement Division to negotiate and execute a one-year contract within a budget of \$368,000. Further request authorization for the Procurement Division to renew the contract for four additional one-year terms.

The proposals were evaluated by the Procurement Committee on May 14, 2021.

PURPOSE:

This contract will provide services by certified public accountants to audit financial statements.

DISCUSSION:

Five proposals were received in response to the Request for Proposals (RFP). The proposal received from RSM US LLP was deemed non-responsive for adding a contingency making their offer revocable.

The selected firm will conduct audits of financial statements for the fiscal year ending September 30, 2021, with the option to audit the County's financial statements for each of the four subsequent fiscal years. These annual audits of financial records are performed as part of the county-wide annual audit by a certified public accounting firm recommended by the Audit Committee as prescribed in Administrative Regulation 6.14, Auditor Selection and Oversight.

It is the policy of the Board of County Commissioners that the external auditors be selected through a competitive process following the guidelines outlined by Florida Statute 218.391, Auditor Selection Procedures.

A timely protest was filed by RSM US LLP and a protest hearing was conducted on June 24, 2021. The protest committee unanimously voted to deny the protest and uphold the scores as accepted at the procurement committee held on May 14, 2021. No further appeal was submitted.
