The Orange County Board of County Commissioners will conduct a public hearing on April 7, 2020, at 2 p.m., or as soon thereafter as the matter may be heard, in the County Commission Chambers, First Floor, County Administration Center, 201 South Rosalind Avenue, Orlando, Florida. You are invited to attend and be heard regarding the following requests by:

Applicant: Ryan von Weller, Hawthorne Park Developer, LLC, Silver Pines Planned Development / Land Use Plan (PD / LUP) Substantial Change — Case # CDR-19-11-388

Consideration: A PD substantial change to request the following waivers from Orange County Code for a portion of Parcel A only:

- 1. A waiver from Section 38-1476(a) to allow 3.412 parking spaces per 1,000 square feet of gross floor area, in lieu of the requirement of 5 parking spaces per 1,000 square feet of gross floor area for shopping centers over 50,000 square feet.
- A waiver from Section 38-1258(d) to allow a maximum building height of four (4) stories or fifty-five (55) feet in height, in lieu of the maximum of three (3) stories or forty (40) feet in height;

pursuant to Orange County Code, Chapter 38, Article VIII, Division 1, Section 38-1207.
