Subject: Award of Invitation for Bids Y22-703-CH, Overland Road Sidewalk Improvements

Project

ACTION REQUESTED:

Approval to award Invitation for Bids Y22-703-CH, Overland Road Sidewalk Improvements Project Installation, to the low responsive and responsible bidder, Schuller Contractors Incorporated, in the total contract award amount of \$664,290.80.

PROCUREMENT:

Work consist of installation of the construction of a five-foot wide sidewalk along the west side of Overland Road from Beggs Road to Clark Road. In addition, drainage pipes along certain driveways will be replaced and several driveways within the right-of-way to provide adequate cross slopes for the sidewalk to meet Americans with Disabilities Act requirements. A 46-foot long precast pedestrian bridge will be constructed downstream of the existing box culvert located just east of the Trailer Park near the south end of the road close to Beggs Road. The Project is located in District 6.

FUNDING:

Funding is available in account number 1023-072-5142-3816.

APPROVALS:

The Public Works Engineering and Business Development Divisions concur with this recommendation.

REMARKS:

Six bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The bid from Gregori Construction Inc. was deemed non-responsive by the Procurement Division based on the analysis provided by the Business Development Division, which identified that the MWBE participation goal was not achieved, and sufficient good faith effort documentation was not provided. The bid from Triple Crown Construction, LLC was deemed non-responsible for not meeting the similar projects criteria. References provided were satisfactory for this type of work and Schuller Contractors Incorporated has been determined to be responsible. Therefore, award is recommended to Schuller Contractors Incorporated.


Y22-703-CH / Overland Road Sidewalk Improvements Project

The Business Development Division evaluated six bids submitted for this project. The Business Development Division completed an M/WBE Availability Analysis. The scope of services for this project had Minority/Women Business Enterprise availability. As a result, the M/WBE goal will remain at 25%. At the time of bid opening, at least 72 M/WBE firms were certified to provide the scope of services at the subcontract level

The apparent low bidder, submitted by Schuller Contractors Incorporated, reported 32.60% in M/WBE participation. They met the 25% M/WBE participation goal. Please note the following certified M/WBE participation:

The second low bidder, submitted by Orange County MBE firm Triple Crown Construction, LLC is bidding as a Prime contractor. Therefore, Triple Crown Construction, LLC is required to self-perform no less than 51 % of the contract per Sec. 17-321 per the M/WBE Ordinance. In the event this requirement is not achieved, other M/WBE's will have to be included to achieve the 25% M/WBE goal. Triple Crown Construction, LLC reported self-performing 54.78% with 5.28% subcontractor's participation on attachment C-2.

The third low bidder, submitted by Gregori Construction Inc., reported 24.04% in M/WBE participation. While they listed Angco, Inc. in their bid, they did not specify scope of service nor dollar amount on attachment C-2 unable to confirm. They did not meet the 25% M/WBE participation goal and did not achieve good faith effort documentation. Please note the following certified M/WBE participation:

The fourth low bidder, submitted by Condor Construction, Corp., reported 26.36% in M/WBE participation. They met the 25% M/WBE participation goal. Please note the following certified M/WBE participation:

The fifth low bidder, submitted by Stage Door II, Inc., reported 1.55% in M/WBE participation. The bidder did not meet the Orange County M/WBE participation goal of 25% and indicated in their bid that they have historically performed all of the other scope of services listed in the bid form on pages 18 to 19. Per the Ordinance, Sec. 17-321, A prime contractor is not required to subcontract out work that it has historically and consistently performed with its own work force.
