Public Notification Map

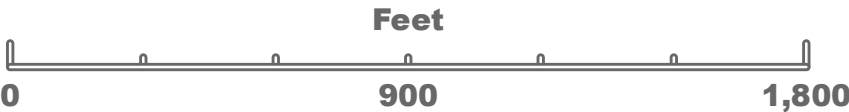
