Consideration: Resolution granting Petition to Vacate # 19-04-011, vacating a 30 foot wide unopened, unimproved and unnamed right-of-way, and a portion of a 60 foot wide unopened, unimproved right-of-way known as Dowman Drive, containing a total of approximately 1.06 acres.
