AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ORLANDO, FLORIDA, RELATING TO A STREET NAME CHANGE; RENAMING "WELLER BOULEVARD" GENERALLY LOCATED WEST OF NARCOOSSEE ROAD BETWEEN VALENCIA COLLEGE AND LAKE NONA HIGH SCHOOL TO "NEMOURS PARKWAY"; DIRECTING AMENDMENTS TO THE OFFICIAL MAPS OF THE CITY OF ORLANDO, FLORIDA; PROVIDING FOR SEVERABILITY, CORRECTION OF SCRIVENER'S ERRORS, AND AN EFFECTIVE DATE.

WHEREAS, there exists a certain continuous segment of public right-of-way within the jurisdictional boundaries of the City of Orlando, Florida, currently known and marked, and also designated on the official maps of the City of Orlando, Florida, as "Weller Boulevard," and

WHEREAS, Nemours Parkway is being extended towards the east to connect to Narcoossee Road, and;

WHEREAS, this street name change will provide a single street name for the entire length of the roadway from Lake Nona Boulevard to Narcoossee Road; and

WHEREAS, the City finds that changing the name of the roadway will improve public safety and emergency response times; and

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF ORLANDO, FLORIDA, AS FOLLOWS:

SECTION 1. STREET NAME CHANGE. After due notice and public hearing, and having met all other conditions precedent in accordance with sections 65.537 and 65.538, Code of the City of Orlando, Florida, and all other applicable law, the name of the public street segment described and depicted in Exhibit "A" to this ordinance is hereby changed from "Weller Boulevard" to "Nemours Parkway."

SECTION 2. AMENDMENT OF OFFICIAL MAPS. The city clerk, the City planning official, the city engineer, and the City zoning official, or their respective designees, are hereby directed to amend the City's official maps in accordance with this ordinance.

SECTION 3. SCRIVENER'S ERROR. The city attorney may correct scrivener's errors found in this ordinance by filing a corrected copy of this ordinance with the city clerk.

SECTION 4. SEVERABILITY. If any provision of this ordinance or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are severable.

SECTION 5. EFFECTIVE DATE. This ordinance takes effect immediately upon final passage.
