Lying within the following described boundaries described as follows:

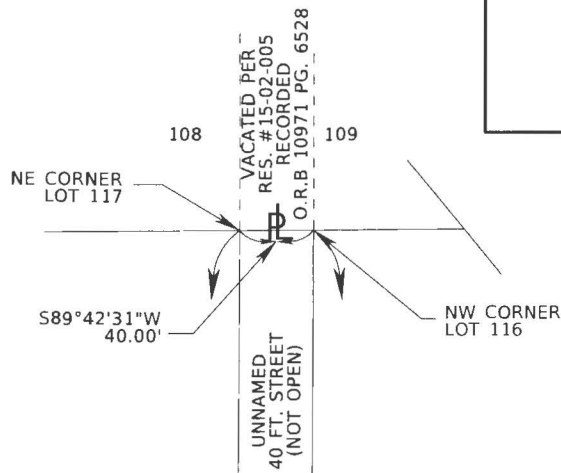
