#### **RECOMMENDATION:**

Selection of one firm and two ranked alternates to provide Design Services for Orange County Barber Park Recreation Center (LEED), Request for Proposals Y23-824-RC from the following firms listed alphabetically:

- Borelli + Partners, Inc.
- KZF Design LLC dba KMF Architects
- OLC Architecture, Interiors and Aquatics

Further request Board authorization for the Procurement Division to negotiate and execute a contract provided that the contract does not exceed the budget of \$1,000,000. Further request authorization for the Procurement Division to formally terminate negotiations with the top ranked firm, if we are unable to come to a favorable negotiated agreement, and commence negotiations with the next ranked alternate, until a successful negotiation is reached.

This item was evaluated by the Procurement Committee on February 28, 2024. Commissioner Nicole Wilson was assigned to the Procurement Committee.

### PROCUREMENT:

This project consists of a new recreation center and gymnasium at Barber Park. The overall project design, including site/building layout and programming, shall incorporate a preliminary energy model, crime prevention through environmental design guidelines, existing neighborhood design and character, universal design principles, building envelope protection for hurricane force winds and a backup generator, as well as LEED standards for new building construction. This project is located in District 3.
