# ACTION REQUESTED:

Approval to award Invitation for Bids Y23-184-TF Grease Traps/Lift Station Cleaning, Maintenance, and Repair at the Orange County Convention Center, to the low responsive and responsible bidder, Brownie's Septic and Plumbing, LLC., in the estimated contract award amount of \$1,916,775 for a three-year term. Further request authorization for the Procurement Division to renew the contract for two additional one-year terms.

In the event the bidder recommended above fails to achieve timely compliance with preaward deliverables, as defined in the Invitation for Bids, including, but not limited to, M/WBE participation sub-contract agreements, State Division of Corporations registration, E-Verify, insurance and bonds, further request authorization for the Procurement Division to award to the next low responsive and responsible bidder as listed in the bid tabulation herein, to the extent practicable and advantageous to the County.

### PURPOSE:

This contract will provide preventative maintenance and repair services to ensure the proper and continued operation of commercial-grade grease traps and components, oil/sand separators, storm drains, and lift stations at the Orange County Convention Center.

### FUNDING:

Funding is available in account number 4430-035-0931-3810.

### APPROVALS:

The Orange County Convention Center and Business Development Division concur with this recommendation.

#### REMARKS:

Four bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The Convention Center performed a technical evaluation of the bids and determined that Brownie's Septic and Plumbing Services, LLC meets the requirements of the solicitation, the bid prices are reasonable, and they have a satisfactory record of performance. Therefore, the award is recommended to Brownie's Septic and Plumbing, LLC.
