Attorney special magistrates appointed to hear issues regarding issues of exemptions, classifications, portability assessment difference transfers, changes of ownership, changes of ownership or control, or a qualifying improvement determination must meet the qualifications provided by Rule 12D-9.010(4), F.A.C., which provides that attorney special magistrates: (i) must not be "an elected or appointed official of the county or taxing jurisdiction of the state, (b) must not represent any party before the VAB in any administrative review of property taxes, and (c) must be a member of the Florida Bar with at least five years' experience in ad valorem taxation (or three years' experience and completed the DOR training).
