SUBJECT: Consent Agenda Item for October 25, 2022 Community Redevelopment Agency Annual Disbursement for FY 2022-23

Florida Statutes Section 163.387(1) provides for the creation of redevelopment trust funds for individual communities. Monies allocated in these funds shall be used to finance or refinance any community redevelopment undertaken pursuant to the approved community redevelopment plan.

Board approval is requested for the disbursement of funds pertaining to the CRAs as detailed in the attached summary. Funds have been included in the FY 2022-23 budget in the appropriate accounting lines.

ACTION REQUESTED: Approval to disburse CRA funds totaling \$65,151,177 to Orange County's Community Redevelopment Agencies.

Notes:

(1) The Orange County CRA payment involves two parts: the 65% portion of the CRA subject to just the countywide millage, and the 35% portion subject to the countywide millage plus the unincorporated county millage. Computation of the 65% countywide portion: (\$172,875,954/1000)*65%*4.4347 mills=\$498,324; computation of the 35% countywide-plus-unincorporated portion: (\$172,875,954/1000)*35%*(4.4347 mills=1.8043 mills)=\$377,501; sum of the two parts: \$498,324+\$377,501=\$875,825 at line E.

(2) The rebate provision in effect for the Eatonville CRA resulted in the return of \$351,172 to the County for FY 2021-22.

(3) The provision for disbursement of surplus incremental revenues in effect for the Orlando III I-4 Conroy CRA resulted in the return of \$2,818,332 to the County in FY 2021-22.

(4) The provision for disbursement of surplus incremental revenues in effect for the Orlando IV I-4 Republic CRA resulted in the return of \$5,500,802 to the County in FY 2021-22.

(5) The amendment to the Orlando/Orange County Interlocal Agreement -- Community Venues, approved by the BCC on Sep 16, 2008, stipulates that the redevelopment agency and

the City of Orlando waive their respective authority to receive increment revenues attributable to CRA V; therefore, no payment is required.

(6) The rebate provision in effect for the Winter Park (I and II) CRA resulted in the return of \$762,566 to the County in FY 2021-22.
