RECOMMENDATION

Selection of C.T. Hsu + Associates, P.A. to provide Countywide Space Study, Request for Proposals Y20-837-FH. Further, request the Board to authorize the Procurement Division to negotiate and award a contract provided that it does not exceed the budget of \$500,000.

This item was evaluated by the Procurement Committee on November 18, 2020. Commissioner Maribel Gomez Cordero was assigned to the Procurement Committee.

PURPOSE

The purpose of this contract is to select a firm to provide a Countywide Space Study to create a feasibility study in order to design new facilities of approximately 80,000-150,000 square feet, depending on plan(s) chosen. This project is located Countywide.

DISCUSSION

Orange County Administrative Services Department is soliciting a feasibility study from qualified architectural and planning consultants specializing in space needs analysis. feasibility studies, and programming to develop a comprehensive plan to reduce dependency on lease space to perform county functions in County-owned facilities.

The Consultant will perform the following services:

- 1. Conduct a needs assessment for all County agencies
- recommended strategy to provide adequate agencies/departments considering current and future staffing levels and supporting equipment
- 3. Consultant should look at the current assets of the County (owned and leased) and compare these to what is needed and where it is needed

4. Consultant shall make recommendations on the effect of COVID-19 on the work force, with the use of work from home and social distancing

One proposal was received in response to this Request for Proposals. To ensure an open and competitive solicitation process, the Request for Proposals was posted on the Orange County website. A query from staff to potential sources that declined to compete on this project resulted in the following findings:

- MSW Consultants: Responded that this project fell outside their area of expertise.
- MRI Architects: Responded that they were unaware of the solicitation posting due to staff changes.
- DeLoaches: Responded that they were unaware of the solicitation posting due to staff changes.
- Carol Wick Consulting: Responded that they were unaware of the solicitation posting due to staff changes.
- Montgomery Consulting Group, Inc.: Responded that they were not asked to participate by any prime, as they would not typically "prime" this project since they do not have the prime experience for the subject services.
- KMF Architects: Responded that they were unable to meet the key personnel qualifications.
- Dignitas Technologies did not respond to our inquiry.
- Eco Preserve did not respond to our inquiry.
- Project Start Management did not respond to our inquiry.
- MSE Group did not respond to our inquiry.
- JHT Inc. did not respond to our inquiry.
- Global 1 Networks, LLC did not respond to our inquiry.
- Diriga Technologies did not respond to our inquiry.
- Hampton and Hartwig LLC did not respond to our inquiry.
- Adacel Technologies did not respond to our inquiry.
